## **\*\*\*\*\* Exhibitor Rules and Regulations \*\*\*\*\***

- 1. A variety of vendors and products will be showcased in our show. However, absolutely NO flea market or garage sale type items will be allowed. Food vendors must sell prepackaged food and NO cooking on site. All product categories shall be reviewed prior to acceptance. We reserve the right to reject items we find in poor taste or any person who does not conform to the regulations. All exhibitors must submit three photos of your products, including one photo of display. Separate pictures for each category to be displayed must be submitted. Exhibitors may only sell work approved prior to the show. Photos will be kept on file.**
- 2. Tables, chairs and electricity are available upon request. Tables will be \$10 each (maximum of 2 tables per booth). Chairs will be \$5 each (maximum of 2 chairs per booth). Electricity will be \$20 per booth. Exhibitors must have a surge protected power strip UL approved for multiple outlet requirements.**
- 3. Show set-up is Sunday, July 25th between 4:30 a.m. – 8:30 a.m. All displays must be ready by no later than 9:00 a.m. Exhibitors must occupy their booth no later than 8:30 a.m. Sunday or be considered a no-show and the space may be given away. Exhibitors must display during entirety of the event. Breakdown will not begin until the end of the show. The exhibitor will occupy their booths at all times. Subletting or sharing of space is NOT permitted.**
- 4. Tables must be covered to the floor on all sides. Displays must be neat and attractive. Candle burning is not allowed. Exhibitors are responsible for the clean-up of their exhibit area.**
- 5. Each exhibitor is responsible for collecting and remitting State sales tax with the Illinois Department of Revenue.**

- 6. Payment is due at the time of application via cash, credit card, certified check/money order, or personal check made payable to SAM Marketing. Mail the application and payment to 476 Old Smizer Mill Rd. #131 Fenton, MO 63026. Full Payment must be made by Monday, July 19, 2010. No refunds will be issued for cancelations. All returned checks will be charged \$50.00.**
  
- 7. Booth assignments will be made by Fairmount Park management with preference given to early registrants. Applications must include full payment to be considered complete. Special requests must be in writing and will be honored to the best of the promoter's ability.**
  
- 8. Fairmount Park reserves the right to rule on all disputes whose judgment will be final.**
  
- 9. All applicants must be at least 21 years of age. Workers under the age of 18 must be supervised by an adult at all times.**
  
- 10. Please include a self-addressed stamped envelope for the return of your confirmation packet. Packets will be mailed about 2 weeks prior to the show and will include your booth space number and other detailed information. If no envelope is included, your confirmation will be emailed to you.**
  
- 11. Management requires all exhibitors and their co-workers to park in designated parking areas ONLY. All parking closest to the entrance is restricted to show attendees (customers) in order to provide ample room and convenient parking for all our potential buyers.**
