**PURSE \$50,000 ADDED (INCLUDES \$10,000 IDOA) FOR FILLIES, TWO YEARS OLD(FOALED IN 2022)** Eligible horses must be registered with the Illinois Department of Agriculture as Illinois Conceived and Foaled or Illinois Foaled Thoroughbreds. By subscription of \$25.00 each horse made on or before October 31, 2023 (fee to accompany nomination). To remain eligible, the following payments must be made: \$100.00 each on or before April 5, 2024; \$250.00 each before August 9, 2024. If the \$25.00 nomination is not made in a timely manner, a late nomination fee of \$250.00 must accompany the \$100.00, April 5, 2024 payment. Nominees to pay \$250.00 each to pass the entry box and \$250.00 each additional to start. Horses that have not remained eligible can supplement to the race with a one time payment of \$1,000 to be paid by time of nomination closing. Weight 122 lbs. Non-winners of \$25,000 allowed 2 lbs.; a race other than maiden, claiming or starter, 4lbs.; maidens, 6 lbs. This race will be limited to 12 starters with preference to (1st) Winners; (2nd) Horses with highest lifetime earnings. Failure to draw into the race will cancel entry fees only. Starters to be named through the entry box by the usual time of closing. A Trophy to the winning breeder and owner. Nominations close October 22, 2024. 6 Furlongs.
