IMPORTANT - PLEASE NOTE: ALL THURSDAY POST TIMES HAVE BEEN CHANGED TO 4:30 PM. A new lasix schedule is available in the racing office.

As of July 8, 2024, HISA rule 2240(b)(2) states Covered Horses placed on the Veterinarians' List for unsoundness, injury, or Epistaxis are prohibited from participating in a Workout for 7 days. Trainers who breeze horses within those 7 days may be subject to sanctions.

Requirements for Pre-race inspections: For Sat. nights (Races 1-3)- Grooms are required to be available for pre-race veterinary inspections starting at 2:30 pm.

All In-Today security signs must be displayed on the corresponding In-Today horse's stall. Failure to follow this procedure will result in fines being issued by the stewards. There will be NO EXCEPTIONS!

Just a reminder, EHV vaccinations are only good for 180 days. Please bring your updated EHV records to the Racing Office. We must have a copy of them and a current Coggins on file! Per IRB rules and HISA regulations, the Racing Office will not be allowed to accept entries for any horse that does not have current vaccinations and Coggins on file.

Pony Coggins and their EHV vaccination records must also be on file. Please turn these records into the Outrider or the Racing Office, once your pony is on the grounds.

Trainers are responsible to alert entry clerks to any gelding changes at time of entry.

Any Blinker Change from LAST Start must be approved by the starter AND declared at time of entry. Per Stewards

Trainers must make an appointment with Dr. Rhoades by Friday for horses needing to work for the vet on Tuesday.

Turn out pens are not to be used before 12:00 pm.

Please see Harry Lynch to nominate for HBPA Groom of the Week and Clean Barn Awards

Per HISA regulations, ALL horses, owners, trainers and jockeys must be registered with HISA. The Racing Office will not be allowed to accept entries on anyone not HISA registered. All racing participants or "covered persons," must register with HISA before racing! Please visit HISAUS.Org to complete your registration.

Reminder: It is against HISA rules to breeze a horse within 7-days of an intra-articular injection. If you inject a horse on Saturday, you cannot breeze the horse until the following Saturday. HIWU's testing program includes the testing of selected horses after routine timed workouts/breezes (Post-Work).

This testing is separate from Vets List testing. Trainers will be notified of selection for Post-Work testing within one hour of a horse's completion of the breeze. For more information about medications that can be used in relation to a routine breeze, visit the News tab on hiwu.org for the latest advisory. Trainers: Please make sure your owners have turned in a 2024 W-9 to the horseman's bookkeeper. Checks will not be issued until the bookkeeper has the required information.

Any deposits of \$10,000 or more to your account via the Horseman's Bookkeeper, must be made in cash or 2 cashier's checks. No checks for \$10,000 or more can be accepted in the Horseman's Bookkeeper's Office.

**Please note that any check requests after the 4th race will be processed the following race day.

Per IRB rules, all occupational licensees must possess a valid 2024 IRB license for the duties that they perform. It is the responsibility of the trainer to ensure that all persons employed by them are appropriately licensed. Failure to do so may result in penalties being assessed against the improperly licensed person and the trainer. All licensees must have their 2024 IRB license in their possession at all times when they are on the grounds. Failure to produce your license upon request of Fairmount Security/IRB personnel may result in disciplinary action by the Stewards.

Any trailer parked next to the barns must be moved immediately. The areas near the barns are FIRE LANES and MUST be kept open! Per the Fire Marshall. Horsemen please note that dogs are not allowed on the backside. Per Management.

*** When you are backtracking, there is to be NO GALLOPING. This will be strictly enforced! Per Stewards
